Old Business:

- > Association management software update by Director Barron
 - We are down to the final hours of fixing the bugs identified by user group
 - Support representative will be here today and Saturday
 - 22 million records imported completed
 - This has taken more time than expected
 - The user group has been very successful to identify problems

- > SFFMA Logo use policy discussion by President Cheshire
 - The concern is the uncontrolled use of the SFFMA logo and those associated with it especially by companies for profit.
 - This is especially concerning when used by for profit groups
 - The discussion is can we or do we want to trademark our Logo and have a use policy.
 - The districts will continue to be able to use our logo as well as others, we just want to know about it.
 - The cost to trademark our Logo is about 260.00 per logo.
- > TCFP Inspector issue update by President Cheshire
 - There is a very spirited discussion over this in the fire service
 - Many want the Inspector 1, 2, and plans examiner certification broken out separately by the TCFP so that the jurisdiction has authority can determine how to use them. There are a great number of large career departments as well as volunteer fire departments. The other opinion is to leave as is.
 - We have sent a letter to the Governor with our support to break the certification out separately.

 - We are in Year 5 of our new building and we are seeing normal wear and tear
 - Some roof and window leaking at a repair cost of about 9,000.00
 - Sales are down a lot this year

 - International vehicle extrication class coming up
 - We have 434 new international members
 - Have been fielding questions on the dues increase proposal
