- Texas fire agency discussion by Bill Gardner
  - Discussion only provided by Chief Gardner
  - Chief Gardner has met with Chief Kidd directly about our concerns
  - Most of the concern surrounds the Hurricane Harvey response
  - Discussion all response agency would come back to TDEM (fire, ems, emergency management)
  - DSHS and TFS some changes being made to streamline process
  - Non-regulatory process or responsibility
  - TFCA has provided a letter of their recommended model
  - This item not going away and will be legislative item for TFCA

  - What prevents anyone from taking our Logo and benefiting from it on their business flyers and cards, shirts, etc.
  - We have no written policy on this.
  - We may want to have all our Logos trademarked
  - A trademark application is about 275.00 per logo without help of an attorney
  - This does not mean folks could not use it, it just means we can allow thru agreement that districts and such can use our logo.
